Thomas G. Masterson was born in Knoxville, Tennessee December 16, 1812. His father Thomas Masterson had died shortly before his birth. His father's death left his wife Sarah Gray Washington, who was pregnant at the time, and their son William Washington Masterson. Thomas G. Masterson graduated from law school in Nashville, Tennessee. In 1832 he moved to Texas become a merchant for a short time before returning to Tennessee. On July 3, 1834 Thomas G. Masterson married Christiana Irby Roane in Nashville, Tennessee.

Thomas G. Masterson moved his family to the port of Velasco on the east side of the mouth of the Brazos River. There he went into the mercantile business with Edwin Waller under the style of Waller & Company by 1837-1838. By 1839 Waller had a home in the new state capital, Austin. Masterson borrowed money from his mother-in-law Ann C. Roane to purchase a small plantation on Oyster Creek owned by Edwin Waller. Unable to make his payments the property was foreclosed on and bought by Roane in late 1840. Waller had been residing on the

property. 1 Masterson had purchased another 200 acres on Oyster Creek from Elisha Maxey in early $1840.^2$

Sarah Groce Wharton of Eagle Island plantation lost her husband William H. Wharton in a tragic accident in 1839. Thomas G. Masterson signed a lease to operate the Eagle Island plantation for 1840 and 1841 for \$3500 per year, Included in contract Masterson was also to pay the taxes for 1840 and 1841. He would be permitted to sell the crops for these two years. The family may have moved to the Eagle Island property for these years.

The Masterson family later moved to the building that was once the American Hotel in Velasco courtesy of Ann C. Roane. The first transaction for this property took place August 18, 1838, but the tavern was built earlier based on receipts from the tavern. Velasco Association president Thomas J. Green sold Lots 3, 4, 5, and 6 to Jeremiah Brown and I. C. Hoskins for the token price of \$180.⁴ Brown, Captain of the *Invincible* during the Texas Revolution, died shortly afterward, and his widow, Rebecca Brown, gave her power of attorney to Hoskins when she went to the United States in December 1842. Three years later in July 1845, Hoskins sold the property with house to Ann C. Roane, the mother of Thomas G. Masterson's wife Christiana for \$1000.⁵ The property was adjacent to the half lot on which Masterson and Waller had a storehouse. Masterson owned many lots in the town site of Velasco at that time.

Thomas G. Masterson held five separate mail contracts from March 1844 to April 1845, totaling 608 miles. The family was still living in Velasco in 1850. The 1850 Federal Census lists the Masterson and Roane families in two separate dwellings in Velasco:

Sister of Christiana Masterson born July 27, 1827 died March 31, 1886 unmarried.

In December 1853, the property and "dwelling in possession of T. G. Masterson" was sold by Ms. Roane to Richard T. Archer of Mississippi, apparently another relative, for \$800. Thomas G. Masterson had become the Deputy Brazoria County Clerk the same year. The family would move to property just below the town of Brazoria on the west bank of the Brazos River. Tax records for 1854 indicate that Masterson owned 87 acres out of the Stephen F. Austin 7 1/3 league tract. The original deed record was not located but it may have been sold to him by the Hawkins heirs, E. M. Pease, or the Terry family. A large two story home was built on the bank of the west Brazos River.




Plat Map Down River from the Town of Brazoria

Thomas G. Masterson would again take up the law profession. He also served as county clerk and chief justice as their family continued to grow.

Thomas G. Masterson became an enrolling officer with the Confederate Army during the Civil War. Four of his sons also joined the Confederate cause. William Masterson, the oldest son, joined the Twenty-second Texas Infantry and was appointed Adjutant by Col. Hubbard. Later he was made Lieutenant, and on the battlefield at Mansfield, Louisiana was promoted to the rank of Captain. He lost his left arm in the battle and was wounded in the side by a ball which caused him considerable pain until it was removed by surgery twenty years later.



James R. Masterson enlisted as a private in Company B 20th Texas Infantry and later became Judge Advocate in the Confederate service. Returning from the service he moved to Harris County where later became a judge.



"Wash" Masterson enrolled at Camp Clark, Texas July 11, 1861 as "5th Sgt" in Co. B, 4th Regiment Texas Infantry, later becoming part of John B. Hood's Texas Brigade. Present at the Battle of Gaines Mill on June 27, 1862 Masterson was promoted to 2n Lt. Wounded in early 1864 he was back in Texas most of that year. He resigned October 26, 1864. Recovering his health January 27, 1865 he was detailed to light duty and March 31, 1861 he was Capt. & A. A. G. to General John A. Wharton. Archibald R. Masterson was seventeen when he joined Hood's Brigade. He was wounded at Gettysburg and two other battles and according to the family was present at the surrender of Robert E. Lee.



Archibald Roane Masterson






Branch Tanner Masterson

Their sisters Ann Terese Masterson died in 1862 and Eloise Masterson in 1863with both being buried in the family cemetery near the home.

During the war Thomas G. Masterson bought Lots 2 & 3 amounting to 243 acres just down river from his homestead. 10 In 1869 Thomas and Christiana sold these two lots to Thomas W. Masterson for \$2500.11

"Wash" Masterson who had married Annie Chalmers in 1865 was interested more in agricultural pursuits than his brothers. He built a sugar mill on this property and raised sugar cane as part of his cash crop naming it the Eureka plantation.

Thomas G. Masterson had built a building near his home which was his office but also used as a law school. Four of his sons would later become lawyers and judges. Some sources say that Christiana Masterson was the actual one that schooled the boys in law.



Thomas W. Masterson went to work cultivating corn and sugar cane on his acreage while living at the homestead. The 1870 Federal Census lists the Masterson families:

Being in the position to know which lands were being foreclosed on or part of probate sales Thomas G. Masterson and several of his sons started to purchase various tracts and lots of land. On Oyster Creek west of Rosharon they bought a tract of land which became a working sugar and cotton plantation. They did not live on this property but William Masterson supervised its operation. A station on the Columbia Tap named Masterson grew up in this area. 12

In 1877 "Wash" Masterson died. Annie Masterson and her children remained on the plantation with her father-in-law. Annie leased the farm land to R. G. Earnest for eight years starting January 1, 1878. This contract was canceled January 1879 by mutual consent. 13 For the year 1880 "John Lang, Eureka plantation made 150 hogsheads of sugar, 300 barrels of sirup and 150 bales of cotton."14

The 1880 Federal Census lists the Masterson families in two separate households:



The 1882 crop was described in a local newspaper: "Eureka plantation, just below Brazoria, is owned by Mrs. Annie and B. T. Masterson, and managed by Mr. Bynum Turner. We found a magnificent crop of ninety acres of plant cane and no stubble." ¹⁵





Thomas G. Masterson died in 1882 and Christiana in 1899. In 1900 Annie T. Masterson was still at the home:

The home later burned down and by 1910 Annie Masterson was living in Houston, Texas as were most of the Masterson brothers except for Branch T. Masterson in Galveston.

The heirs turned over the property to the Magnolia Petroleum Company [Texaco] well after the turn of the century. Those family members buried in the homestead graveyard on the homestead were removed to the Glenwood Cemetery in Houston, Texas. The company sold the acreage which included the homestead and the Eureka plantation to George G. Badge in 1941. 16

In 1946 C. A. and Dixie S. Vollbaum purchased the property. ¹⁷ Although portions of the property have been sold off over the years Glenn Vollbaum currently still owns that part of the homestead on which the old Masterson house sat. The remains of an old iron fence half buried in silt from the Brazos River still marks the location of the family cemetery. The remains of the infant Laura R. Masterson could possibly still could be there. Scattered bricks can be seen just under the surface but the location has not been surveyed archeologically.
